Representation and Advocacy

- Supported and actively encouraged our members to ask their member to be a part of CCIWA's Payroll Tax Campaign. RCCIWA has long advocated for raising the threshold of payroll tax and changing the way it is applied. PRT has not kept up with inflation and is a genuine inhibitor to business growth for so many regional businesses. Please sign up to CCIWA's campaign to help our collective voice.
- Contributed to Federal Treasury's business round table consultation on the white paper that is being developed as a result of the National Jobs and Skills Summit. We contributed strongly with a clear message that regional WA is unique and that a bespoke model must be considered when looking at delivering training and workforce development programs and initiatives for businesses in Regional WA, and to ensure they are locally led. It has been our experience that WA does needs programs to be designed differently.

Key Issues for Regional Businesses

- The issues below are the ones that are of strongest concern all regional business communities in WA right now. In all meetings, conversations and at any opportunity, we explain in detail what the impact is and offer suggested solutions as well advocate for support, to try and ease the pressure.
 - Critical labour shortage just not enough people in regional WA
 - Critical lack of housing and accommodation this seems to be number 1 at the moment
 - Lack of Childcare
 - Ongoing impacts of COVID long term business fatigue
 - Rising costs of doing business
